

# UK 100 Daily Update Wednesday 17th May 2023

## UK 100 Fundamentals:

The UK 100 initially managed small gains to start the week off, rising steadily from its Monday opening levels at 7,752 to register a high early Tuesday at 7,808 (+0.8%). Those gains were soon reversed as losses in energy and financial stocks combined with weakness in UK 100 firms exposed to China, after another below expectation release of April industrial output and retail sales data in the country re-enforced concerns its economy is losing momentum. Vodafone was the index's biggest faller (-7%) yesterday after announcing weaker than expected earnings and 11,000 job cuts. This all resulted in the UK 100 closing down 0.7% at 7,732.



Today sees earnings releases from UK 100 constituents **Experian, Sage and British Land**, in the morning, while the **Governor of the Bank of England speaks at 1050 BST** to the British Chamber of Commerce. Traders will be looking for further insight from Governor Bailey into the reasons behind the recent 25bps rate hike, and what comes next on inflation and interest rates. Elsewhere general risk sentiment is being driven by a debt ceiling stand off in the US Congress which could lead to the US treasury running out of funds as soon as 1st June.

## UK 100 Technicals:



### Daily Technicals:

Recent price activity has seen consolidation develop as a reaction to declines from 7935 (Apr 21st high).

While prices remain below 7812 (Bollinger mid-average), which is a resistance focus on the topside, Tuesday's weakness threatens to resume potential for a deeper retracement. This can see tests of 7657 (38% Mar/Apr strength) even 7573 (deeper mid-point) if this gives way.

**To the upside**, closes above 7812 are needed to open scope back to 7935 (Apr 21st high).
